APPLICATION FEE

A Fifty Dollar (certified funds only – cashier's check from your bank or a money order) **non-refundable** application fee must be paid at the time the application is submitted. All adults (18 years of age or older) who will be living in the property, must qualify independently on a separate application to be considered.

CREDIT HISTORY

During our rental process we will pull a credit check of your FICO 2 score. We are looking for a 600 or above with **NO** delinquencies. We will review scores of 550 to 600 with no delinquencies in the past 3 to 5 years; however, we would require an increased Security Deposit. Credit reports with N/A scores will also be subject to an increased Security Deposit. These qualifications include but are not limited to such things as:

- There can be no bankruptcy in the past 3-5 years.
 - *In the event you did have a bankruptcy, credit must now be re-built and in good standing.
- Collections and/or judgments on a credit report are immediate grounds for denial.
- Reported activity on any accounts on your credit must be current and in good standing.
- Applications with no established credit must meet income and rental criteria to be considered.
- North Carolina Law allows any landlord to collect up to 2 months rents as a security deposit.

DEBT TO INCOME RATIO

We require your debt-to-income ratio to be 50% or less. This is determined by taking all your debts to include rents (credit cards, car loans, personal loans, etc.) and we add these up and divide by your monthly gross income to determine your debt-to-income ratio. Your gross income should equal three times the rental rate.

RENTAL HISTORY

Any negative rental history can be automatic grounds for denial of an application. Negative rental history includes but is not limited to the following: NSF checks, numerous late pays, noise complaints, unfulfilled lease term(s), and eviction proceedings.

PETS/ANIMALS (PET SCREENING IS REQUIRED FOR ALL APPLICANTS - SCAN QR CODE TO COMPLETE YOUR PROFILE)



It is required to list all pets/animals of any size, kind, or type including both caged animals and aquatic. If you do not have a pet/animal, you must complete a **NO PET** screening profile.
